- No building activity shall be signed off until As-built information is **complete**.
- As-built form (reverse side) **must** be submitted at the time of inspection for sign-off.
- All activities in the public right-of-way or City easement areas will require a **Right-of-Way Disturbance Permit**, to be issued concurrently with this document.
- All paved road crossings shall be backfilled with CDF per current City Standards.
- **Contact** must be made **24 hours in advance** with inspector (no messages).
- Call Underground Utility Locate Center 48 hours in advance of construction – 800-424-5555.
- Permit must be kept available on site at all times.
- All work will be performed in accordance with current City Standards and this permit.
- In the event of any violations of the above conditions, **Stop Work** orders may be posted.
- **Septic Tanks** must be sand-filled or removed from site. **No sign off until complete.**

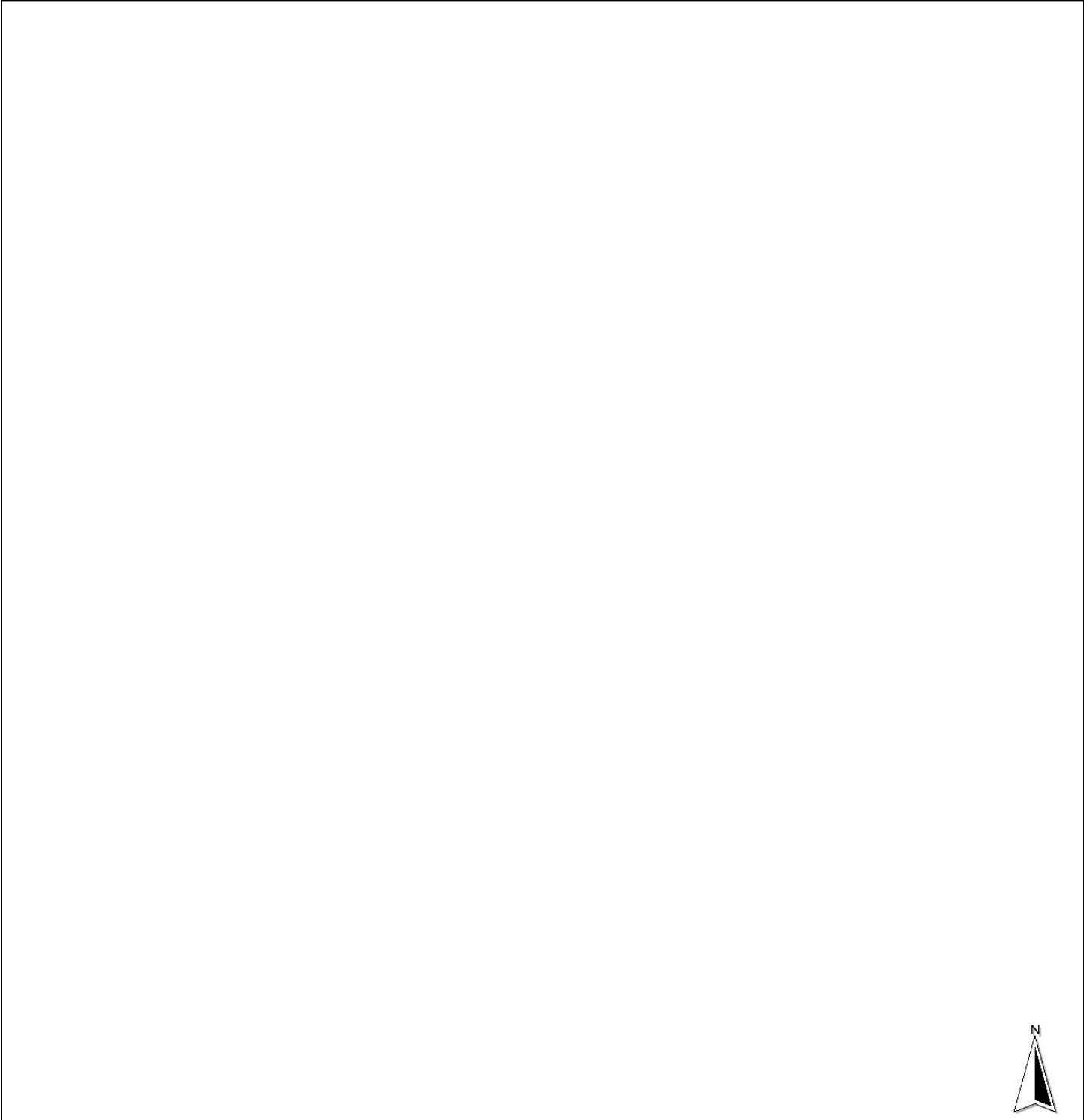
